

The Hungry Boar Giveaway & UGC Giveaway Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. Participants of the promotion agree to be bound by these Terms and Conditions.

Promoter: Golden Acre Foods Limited, parent company and owner of The Hungry Boar brand.

A. The Hungry Boar Giveaway Competition

Eligibility:

1. The Hungry Boar Giveaway Competition is open to residents of the United Kingdom aged 18 and over. Validity of entrants may be checked.
2. The competition is not open to employees of the Promoter, its affiliates or agents, the immediate families of such employees, or any other person connected with this promotion.

Promotional Period:

3. Entries for The Hungry Boar Giveaway Competition will be accepted from midnight GMT on 28th February 2025 until midnight GMT on 31st May 2025.
4. There will be one prize draw each month, taking place on:
 - 28th March 2025
 - 30th April 2025
 - 2nd June 2025
5. The winners will be notified within two working days of the prize draw, specifically:
 - 1st April 2025
 - 2nd May 2025
 - 4th of June 2025

How to Enter:

6. Entry Method: Entries will only be accepted via the official entry form located on The Hungry Boar's website: www.thehungryboar.co.uk.
7. Eligibility Criteria: To qualify for entry, participants must:
 - a) Provide their full name and Instagram handle in the relevant fields on the entry form.
 - b) Follow @TheHungryBoarUK on Instagram at the time of entry and at the time of winner selection.
8. Entry Validity & Responsibility:
 - a) The Promoter is not responsible for entries that are lost, late, misdirected, incomplete, corrupted, or inaccurate due to any technical or human error.
 - b) Entries that do not meet the specified requirements will be disqualified without notice.
9. Entry Limitations: Only one entry per person will be accepted. Multiple entries, automated entries, or entries made via third-party services will be disqualified.

Prizes:

10. Prize Structure: There will be a total of 30 winners (10 winners per month). Each winner will receive:

- 2 packs of each flavour of The Hungry Boar's Sticklers, including:

 - 2x Pork Sticklers
 - 2x Flamin' Peri Peri Sticklers

11. Non-Transferability & Dietary Preferences: Prizes are non-transferable and cannot be exchanged for cash or other alternatives, either in whole or in part. No substitutions will be made on the grounds of dietary preference, including those based on ideology, religion, or health. Winners are responsible for reviewing the ingredients and allergens of the products. The Promoter accepts no liability for any adverse reactions caused by the consumption of the prize.

12. Substitution Policy: In the event that a listed prize item is unavailable due to circumstances beyond the Promoter's control, the Promoter reserves the right to substitute it with an item of equal or greater value.

13. Food Safety & Perishability: The Hungry Boar's Sticklers are shelf-stable but should be consumed before the expiration date printed on the packaging. No refrigeration is required before opening. The Promoter is not responsible for any spoilage due to delays in delivery or improper storage by the recipient.

Random Prize Draw & Notification:

14. Winners will be randomly selected via a third-party app in a monthly prize draw, including all valid entries from that month.

15. The winners will be notified via Instagram direct message from the official @TheHungryBoarUK account.

16. To claim the prize, the winner must respond to the message and provide a valid UK delivery address.

17. The winner's personal details will only be used for the purpose of fulfilling the giveaway and will be handled in accordance with the Promoter's Privacy Policy [[Golden Acre Foods Customer Privacy Notice](#)].

18. The selected winner must accept the prize by responding within five working days of being notified.

19. If the winner does not respond within five working days, the Promoter reserves the right to randomly select an alternative winner from the remaining valid entries.

20. Before selecting a replacement, the Promoter will make all reasonable attempts to contact the original winner, sending at least one follow-up message within the claim period.

21. If the selection process is restarted due to non-response, the Promoter will clearly communicate this to ensure transparency.

B. UGC Giveaway Competition**Eligibility:**

1. The UGC Giveaway is open only to winners of The Hungry Boar Giveaway Competition. Eligibility may be verified.

How to Enter:

2. Participants must share their giveaway prize on Instagram as a grid post, story, or reel and tag @TheHungryBoarUK.
3. If an Instagram account is private, participants must accept The Hungry Boar UK's follow request for verification.
4. Entries must be submitted between 28th March 2025 and 30th June 2025.

Prizes & Winner Notification:

5. Each eligible participant, as per the entry mechanic above, will receive x1 £5 Amazon voucher.
6. Eligible participants will be notified via Instagram direct message from the official @TheHungryBoarUK account.
7. To claim the prize, the winner must respond to the message and provide a valid email address.
8. The winner's personal details will only be used for the purpose of fulfilling the giveaway and will be handled in accordance with the Promoter's Privacy Policy [[Golden Acre Foods Customer Privacy Notice](#)].
9. The selected winner must accept the prize by responding within five working days of being notified.
10. If the winner does not respond within five working days, the Promoter reserves the right to withdraw the £5 Amazon voucher prize.

12. The Promoter is not responsible for undelivered or lost vouchers due to incorrect email information or technical/IT failures.

1. Right to Modify, Suspend, or Withdraw:
 - a) The Promoter reserves the right to modify, suspend, or withdraw these promotions (including changes to prizes or conditions) in the event of exceptional circumstances beyond its control.
 - b) Any changes will be communicated promptly via The Hungry Boar's website or @TheHungryBoarUK Instagram account.
2. Personal Data Handling & Retention:
 - a) Personal data collected for these competitions will be used solely for the purpose of administering the competitions and fulfilling prizes.
 - b) All personal data collected will be securely deleted within 10 working days after the final prize has been delivered.
3. Data Protection & Third-Party Sharing:
